




The Summary of Benefits and Coverage (SBC) document will help you choose a health [plan](#). The SBC shows you how you and the [plan](#) would share the cost for covered health care services. **NOTE: Information about the cost of this [plan](#) (called the [premium](#)) will be provided separately. Important Questions	Answers	Why This Matters:
What is the overall <a href="#">deductible</a> ?	\$7,000/Individual or \$14,000/Family	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes	This plan covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. For example, this plan covers certain preventive services without <a href="#">cost sharing</a> and before you meet your <a href="#">deductible</a> . Are there other <a href="#">deductibles</a> for specific services?	No	You don't have to meet other deductibles for specific services.
What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	\$8,550/Individual or \$17,100/Family	The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services. If you have other family members in this plan, they have to meet their own <a href="#">out-of-pocket limits</a> until the overall family <a href="#">out-of-pocket limit</a> has been met.
What is not included in the <a href="#">out-of-pocket limit</a> ?	<a href="#">Premiums</a> , <a href="#">balance-billing</a> charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the <a href="#">out-of-pocket limit</a> .
Will you pay less if you use a <a href="#">network provider</a> ?	Yes. See <a href="http://www.togethercchp.org/find-a-doc">www.togethercchp.org/find-a-doc</a> or call 1-844-201-4672 for a list of <a href="#">network providers</a> .	This plan uses a provider network. You will pay less if you use a provider in the plan's network. You will pay the most if you use an <a href="#">out-of-network provider</a> , and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays ( <a href="#">balance billing</a> ). Be aware, your <a href="#">network provider</a> might use an <a href="#">out-of-network provider</a> for some services (such as lab work). Check with your provider before you get services.
Do you need a <a href="#">referral</a> to see a <a href="#">specialist</a> ?	No	You can see the in-network <a href="#">specialist</a> you choose without a <a href="#">referral</a> .

<b>If you need mental health, behavioral health, or substance abuse services</b>	Outpatient services	\$60/visit	Not covered.	\$60 copay/office visit. 50% after <u>deductible</u> for other outpatient services. Prior Authorization required for some services.
	Inpatient services	50% after <u>deductible</u>	Not covered.	Prior Authorization required for some services.
<b>If you are pregnant</b>	Office visits	50% after <u>deductible</u>	Not covered.	<u>Cost sharing</u> does not apply for <u>preventive services</u> . Maternity care may include tests and services described elsewhere in the SBC (e.g. ultrasound).
	Childbirth/delivery professional services	50% after <u>deductible</u>	Not covered.	None.
	Childbirth/delivery facility services	50% after <u>deductible</u>	Not covered.	None.
<b>If you need help recovering or have other special health needs</b>	<a href="#">Home health care</a>	50% after <u>deductible</u>	Not covered.	Limited to 60 visits per calendar year. Prior Authorization required.
	<a href="#">Rehabilitation services</a>	50% after <u>deductible</u>	Not covered.	Visit limits per calendar year: pulmonary = 20 visits; physical, occupational, and speech therapies = 20 visits each; cardiac rehabilitation = 36 visits.
	<a href="#">Habilitation services</a>	50% after <u>deductible</u>	Not covered.	Visit limits per calendar year: pulmonary = 20 visits; physical, occupational, and speech therapies = 20 visits each.
	<a href="#">Skilled nursing care</a>	50% after <u>deductible</u>	Not covered.	Limited to 30 days per stay in a skilled nursing facility & 60 days per calendar year in an inpatient rehabilitation facility. Prior Authorization required.

	<a href="#">Hospice services</a>	50% after <u>deductible</u>	Not covered.	Prior Authorization required.

	Children's glasses	50% after <u>deductible</u>	Not covered.	1 pair of lenses every 12 months, 1 pair of frames (in the Pediatric Eyewear Collection) every two years.

### Does this plan provide Minimum Essential Coverage? Yes

**This is not a cost estimator.** Treatments shown are just examples of how this [plan](#) might cover medical care. Your actual costs will be different depending on the actual care you receive, the prices your [providers](#) charge, and many other factors. **Peg is Having a Baby**

(9 months of in-network pre-natal care and a hospital delivery)

- [Diagnostic tests](#) (*ultrasounds and blood work*)

In this example, Peg would pay:

**Managing Joe's Type 2 Diabetes**

(a year of routine in-network care of a well-controlled condition)

- Hospital (facility) [\[cost sharing\]](#) 50%
- Other [\[cost sharing\]](#) 50%

This EXAMPLE event includes services like:

- [Primary care physician](#) office visits (*including disease education*)
- [Diagnostic tests](#) (*blood work*)
- [Prescription drugs](#)
- [Durable medical equipment](#) (*glucose meter*)

<b>Total Example Cost</b>	<b>\$5,600</b>

In this example, Joe would pay:

(in-network emergency room visit and follow up care)

- Other [\[cost sharing\]](#) 50%

This EXAMPLE event includes services like:

- [Emergency room care](#) (*including medical supplies*)
- [Diagnostic test](#) (*x-ray*)
- [Durable medical equipment](#) (*crutches*)
- [Rehabilitation services](#) (*physical therapy*)
